		CELLPHONES OR ANY FORM OF ELECTRONIC USE THAT RESEMBLES A CELLPHONE IS NOT PERMITTED DURING ANY CLASS.
		THE USE OF EARBUDS/HEADPHONES IS NOT PERMITTED UNLESS THE TEACHER ALLOWS THE USE. EARBUDS/HEADPHONES MAY BE USED DURING A STUDY HALL PERIOD FOR CONCENTRATION PURPOSES OR LISTENING TO AUDIO. HOWEVER, NO AUDIO CAN BE GENERATED FROM A CELLPHONE OR ANY FORM OF ELECTRONIC USE THAT RESEMBLES A CELLPHONE.
		ALL CELLPHONES MUST BE SILENCED AND PLACED IN A TEACHER-PROVIDED CONTAINER EACH CLASS PERIOD.
		IF A STUDENT NEEDS TO CONTACT SOMEONE, THEY ARE REQUIRED TO BE EXCUSED TO THE OFFICE BEFORE CALLING. CELLPHONES ARE NOT TO BE USED TO CALL HOME IN THE CASE OF ILLNESS. OFFICE PERSONNEL WILL CALL HOME FOR THE STUDENT IF A NEED IS DETERMINED.
		IF A STUDENT NEEDS TO BE REACHED, OFFICE PERSONNEL WILL RECEIVE THE CALL AND WILL RELAY THE MESSAGE OR PULL THE STUDENT FROM CLASS.
		CELLPHONE USE IS PERMITTED DURING THE LUNCH PERIOD, BETWEEN CLASSES, AND AT THE END OF THE SCHOOL DAY.
		FAILURE TO ADHERE TO THIS POLICY WILL RESULT IN REVOCATION OF THE CELL PHONE BY THE TEACHER AND SUBMITTED TO THE OFFICE FOR SAFEKEEPING UNTIL A PARENT/GUARDIAN IS AVAILABLE TO RETRIEVE IT. THIS MAY RESULT IN DISCIPLINARY ACTION.
